Executive Demographic Summary Report

Population

The current year population for the Town of Hebron is estimated at 9,500. The 2000 Census revealed a population of 8,610, and in 1990 it was 7,079 representing a 21.6% upward change. It is estimated in the Town Plan of Conservation and Development that the population in this area will be 10,250 in 2014, representing a change of +7.9% from 2010. The current population is 50.4% male and 49.6% female. In 2009, the median age of the population in this area was 39.3, compared to the US median age which was 37.1. The population density is 241.1 people per square mile.

Households

There are currently 3,167 households in Hebron. The Census revealed household counts of 2,993 in 2000, up from 2,335 in 1990, representing a change of 28.2%. It is estimated that the number of households in this area will be 3,236 in 2014, representing a change of 2.2% from the current year. For the current year, the average household size in this area is 2.84 persons.

In 2009, the median number of years in residence in this geography's population is 6.68. The average household size in this geography was 2.84 people and the average family size was 3.14 people. The average number of vehicles per household in this geography was 2.3.

Income

In 2009, the median household income in the Town of Hebron was \$96,295, compared to the US median which was \$53,684. The Census revealed median household incomes of \$75,123 in 2000 and \$56,218 in 1990 representing a change of 33.6%. It is stimated that the median household income in Hebron will be \$104,798 in 2014, which would represent a change of 8.8% from the current year.

In 2009, the per capita income in this area was \$39,735, compared to the US per capita, which was \$26,485. The 2009 average household income for this area was \$112,606, compared to the US average which was \$69,346.

Race & Ethnicity

In 2009, the racial makeup of the Town of Hebron was as follows: 97.4% White; 0.6% Black; 0.6% Native American; 0.7% Asian/Pacific Islander; and 0.1% Other. Compare these to the US racial makeup which was: 73.9% White, 12.4% Black, 0.8% Native American, 4.4% Asian/Pacific Islander and 5.4% Other.

People of Hispanic ethnicity are counted independently of race. People of Hispanic origin make up 1.4% of the current year population in this selected area. Compare this to the US makeup of 15.6%. Changes in the population within each race and ethnicity category from the 1990 Census to the 2000 Census are as follows: -21.4% American Indian, Eskimo, Aleut Population; 96.2% Asian, Pacific Islander; -19.4% Black; 37.3% Hispanic Ethnicity; 41.7% Other; White 20.8%.

Housing

The median housing value in the Town of Hebron was \$186,829 in 1990, compare this to the US median of \$78,382 for the same year. The 2000 Census median housing value was \$168,261, which is a -9.9% change from 1990. In 1990, there were 2,070 owner occupied housing units in this area vs. 2,669 in 2000. Also in 1990, there were 265 renter occupied housing units in this area vs. 324 in 2000. The average rent in 1990 was \$625 vs. \$572 in 2000.

Employment

In July of 2010, there were 5,632 people over the age of 16 in the labor force in the Town of Hebron. Of these 93.0% were employed, 7.0% were unemployed, 22.0% were not in the labor force and 0.0% were in the Armed Forces. In 1990, unemployment in this area was 3.5% and in 2000 it was 2.2%.

In 2009, there were 1,891 employees in Hebron (daytime population) and there were 275 establishments. or this area in 1990, 70.2% of employees were employed in white-collar occupations and 29.8% were employed in blue-collar occupations. In 2000, white collar workers made up 76.7% of the population, and those employed in blue collar occupations made up 23.3%. In 1990, the average time traveled to work was 21 minutes and in 2000 it was 32 minutes.
